Article 1: Subject of the contract

The subject of the contract is the **External services for elaboration and printing promotional and awareness materials LOT1, LOT2** as indicated in the contractor's offer – "Part B: Format of offer to be provided by the tenderer"

Article 2: Contract value

The total contract value for implementation of services indicated in the Article 1 is: 14767,90 EUR, (including VAT), as follows:

LOT 1 Elaboration and printing promotional and awareness materials services– 13447 EUR (including VAT),

LOT 2 Services editing study – 1320,90 EUR (including VAT).

For Romanian Partners:

In accordance with IPA implementing regulation, for Romanian partners VAT can be an eligible expenditure. The Contracting Authority will pay the unit prices, as stated in the Financial Offer, and will pay the VAT if the VAT is clearly identified on the invoices.


Article 3: Contracting documents

The contractor will provide contracting authority with the brief report on execution of the services, which will represent the basis for issuing interim and balance final payment.

The interim payments and one final payment for LOT1 and LOT 2 will be based on the invoices and the reports of services execution elaborated by the Contractor.

For LOT 1 from date of signing the contract **until** not later than 05.08.2021.

For LOT 2 2 months after Commencement order for service (after the elaboration of the study by the provider elaboration study services).
